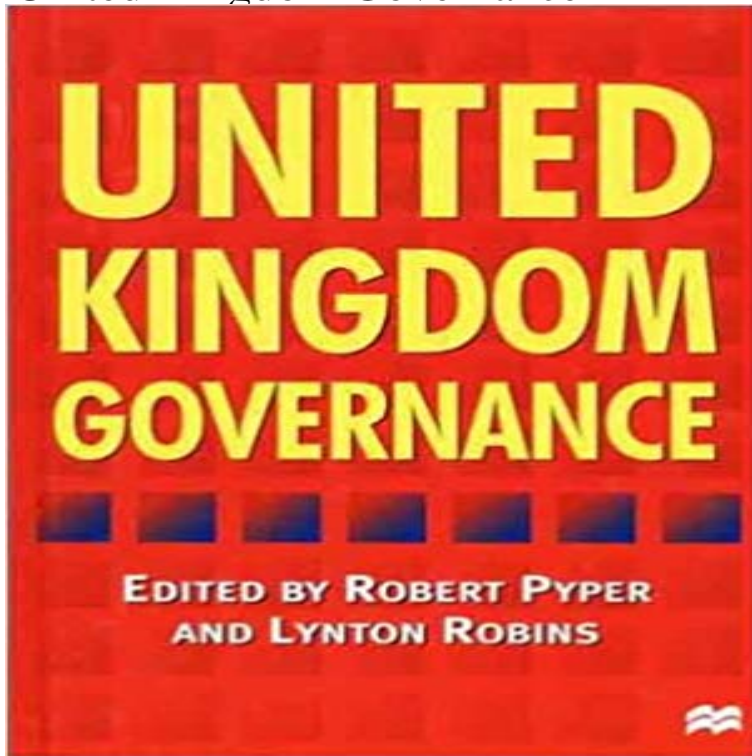


## United Kingdom Governance
